

To participate in *InfoTech-2025*, you must register and upload *Full-length paper* in the manuscript management system **before May 20th**, 2025: (Template could be downloaded from the conference web site: http://e-university.tu-sofia.bg/e-conf/?konf=232).

The papers will be evaluated for similarity and blind reviewed for their scientific content by the members of the Int'l Program Committee and authors will be notified (by e-mail) for acceptance or rejection. Acceptance will be based on quality, relevance, and originality. The revised and final versions of accepted papers must be submitted in **camera-ready form** before **July 15th**, **2025**. For procedures, see the deadlines below.

The accepted reports with participation in the virtual forum will be included in the e-Proceedings with publication in IEEE Xplore Digital Library and indexing in Scopus. InfoTech-2025 Proceedings, vol. 39 (ISSN 1314-1023) will be published with abstracts of all accepted reports.
